TERMS AND CONDITIONS

All course works remain the property of Progress Dog Training and may not be reproduced in any form without written permission from Progress Dog Training.

Assignments will be despatched upon successful completion of the prior assignment. Some courses only require you to submit work once it is all completed. We aim to support you achieve success and will assist where required but the work must be completed by the student. If an assignment is unsatisfactorily completed, we will return it with comments and suggestions on how to improve your work for assessment when you re-submit it. Assignments must be submitted by email and feedback will be provided by email.

For assignments submitted as part of a Tutor Led Course or Distance Learning Course there is a time limit of 2 years for submitting your work. The first day is the day you start your course. If you do not submit any work or complete your course within this time you will need to re-register and pay the associated costs.

Feedback on assignments submitted as part of a tutor led course or Distance Learning Course will be assessed as quickly as possible, usually well within 2 weeks but no longer than a maximum of 4 weeks.
